

# Taramana

The charity Taramana, created in 2005 to support the studies of two Cambodian orphans, "**Tara**" and "**Mana**", is today a French-Cambodian NGO composed of about twenty employees and volunteers, supporting the education and improving the living conditions of more than 200 children from the age of 5 until the end of their studies.

These children are from the slum of Boeng Salang, located at the north of Phnom-Penh (Cambodia). It is thanks to many sponsors and donors that children can now hope for a better future.

## Taramana in action!

### Education

Education, in addition to that received at the public school, focuses on Khmer, English, French, computer courses, as well as on artistic and sports activities.



### Health and nutrition

The children have access to a daily healthy meal at the center's cafeteria. Moreover, they receive medical care: vaccinations, dental care, intestinal deworming, health education ...

### Social support

Taramana supports the neediest families with rice distribution and also donates towards current expenses (electricity, water, ...)



### Extra-curricular activities

Rugby, soccer, yoga, hip-hop, theater, dance, music...

## What does it mean to sponsor a child at Taramana?

Sponsorship is how children from disadvantaged backgrounds can have free access to education, medical care and basic food and sanitation at the Taramana Magdalena Center, opened in 2016

Taramana offers two types of sponsorship:

### The collective sponsorship

allows the charity to welcome all children in the best conditions. It enables Taramana to offer them the opportunity of having additional English, Khmer and computer science classes, a discovery of the French language, an access to health care, free school equipment and an openness to the world through various sports and cultural activities. It is also an effective way of ensuring the smooth running of the center and its durability.
